FINANCIAL REPORT: Moved by Salem, seconded by Vivas, to accept the financial report for August 2025 as presented. Roll call. Voting "aye" were Vivas, Jacob, Salem, Roberts, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to consider a Conditional Use Permit application by Javier Ramirez Zamora for an automotive repair shop located at 119 West Pacific Street. Brecks stated the applicant would like to repair vehicles. He gave a history of the code violations at the locations over the years, noted that public comments received in his office include a desire to clean up the downtown area by not having repair shops and salvage yards there. The applicant appeared to explain the plan for site. The public hearing was closed. Following discussion, moved by Salem, seconded by Roberts, to deny the Conditional Use Permit application for an automotive repair shop at 119 West Pacific Street. Roll call. Voting "aye" were Vivas, Jacob, Roberts, Salem, Fagot. Motion carried.

PUBLIC HEARING: Mayor Fagot opened a public hearing to review and take comments on the 1&6 Year Street Improvement Plan. Pepplitsch reviewed the plan. There were no public comments, and the public hearing was closed. Resolution No. 2025-23 was presented. Moved by Roberts, seconded by Jacob, to approve Resolution No. 2025-23. Roll call. Voting "aye" were Vivas, Jacob, Roberts, Salem, Fagot. Motion carried.

CONSERVATION EASEMENT: Pepplitsch reviewed a request by the Central Platte NRD to amend a conservation easement. Following discussion, Resolution No. 2025-24 was presented. Moved by Vivas, seconded by Salem, to approve Resolution No. 2025-24. Roll call. Voting "aye" were Vivas, Jacob, Roberts, Salem, Fagot. Motion carried.

EXECUTIVE SESSION: Moved by Vivas, seconded by Salem, to enter executive session at 5:42 p.m. to discuss contractual negotiations. Roll call. Voting "aye" were Jacob, Salem, Vivas, Roberts, Fagot. Motion carried.

Moved by Salem, seconded by Roberts, to enter open session at 6:44 p.m. Roll call. Voting "aye" were Jacob, Roberts, Vivas, Salem, Fagot. Motion carried.

ADJOURNMENT: There being no further business to come before the Council, Fagot declared the meeting adjourned.
