

What's going on at West 20th/North Erie? (near Park Avenue Estates)



Infrastructure work began the last week of July on Phase 1 of the new Northwest Third addition residential neighborhood. This addition lies generally north and south of 20th street from Erie Street to approximately 1,220 feet to the west. Phase 1 development includes the extension of utilities and paving as shown in the graphic to the left. This project will create 17 ready-to-build single family residential lots, and an 8 acre parcel scheduled as a planned unit development for non-income-restricted owner occupied senior (55+ age) housing. This development is part of the New Neighborhoods Initiative program, a partnership between the Nebraska Department of Economic Development and the City of Lexington. The program provides \$500,000 in grant funding to support land acquisition, preparation, and utility extension costs. West Elm & West Spruce Streets



Work began in July on Paving District 09-02, West Spruce and West Elm Streets, just west of South Adams Street, as well as the block-long north/south connecting streets Ontario and Price Drive. The area has endured gravel roads for many years, and been on the City's list of projects to complete. The project includes small portions of water line rehab. Following these improvements toward the end of summer, the nuisance of gravel streets will be a thing of the past. A portion of the costs will be assessed to abutting property owners, in proportion to the benefits received from the improvements.



City Employees organized a reception for Clark


on July 29 at the Grand Generation Center.

EnergyWise Tip: Reduce "Phantom" Energy Loss

Did you know that even after you push the OFF button on your TV remote, that high-tech, flat screen, although darkened, may continue to draw electric power costing you money unnecessarily? It's a distinct possibility. Many of today's electric-powered appliances and electronic components, like televisions and computers, continue to use power after they are shut off. The amount of energy a typical household may lose to these "phantom" loads can range from 4 to 12 percent, according to recent electrical industry studies.

Individual rates of loss will vary depending upon the number and efficiency of a home's electric and electronic appliances and equipment, and on a home owner's individual usage patterns. But, for the average household, the cost is approximately \$70 per year paying for electricity to run household components that are supposedly turned off.



With that in mind, May's EnergyWiseSM tip offers you ways to reduce phantom energy loss in your homes.

According to the U.S. Department of Energy, NPPD and your local electric utility, here are some things you can do to reduce phantom loads and become more energy efficient.

- In the average home, 75 percent of the electricity used to power home electronics is consumed while the products are turned off. This loss of energy can be avoided by unplugging the appliance or using a power strip to cut all power to the appliance.
- Unplug battery chargers when the batteries are fully charged or the chargers are not in use.
- Look for energy-saving ENERGY STAR[®] home electronics and appliances when shopping for these items.
- According to the U.S. Department of Energy, an ENERGY STAR[®] computer uses 70 percent less electric energy than computers without this designation. If left inactive, ENERGY STAR[®] computers enter a low-power mode. Spending a large portion of time in low-power mode saves energy and helps equipment run cooler and last longer.

A common misconception is that equipment lasts longer if it is never turned off. This is not true. If you are not using your electric-powered equipment, turning it completely off is always the better energy-saving strategy.

Lexington Utilities System wants you to get the most value for your money, each and every time you turn on a switch. It costs far less to save a kilowatt-hour than it does to build a new power plant to generate one.

Kim Brown will be presenting the program, "A Visit from the Real D. W."




NEBRASKA OVERDRIVE LIBRARIES

Beginning July 13, library patrons, who have a library card from the Lexington Public Library, will be able to check out e-Books by accessing **Overdrive** on the library's website. Compatible eBook devices include most Windows desktop, laptop, or notebook computers and Mac desktop or laptop computers. Barnes and Nobles Nook, Kobo eReader, and the Sony Reader are also compatible. Check the Overdrive Device Resource Center for more compatibility information. Audio books are still available by accessing Overdrive on the library's website www.lexingtonlibrary.org. Checking out either audio books or eBooks using Overdrive is a free service of the Lexington Public Library. Lexington partners with the OverDrive, Inc., and the Nebraska Library Commission, to offer the download services.

Applications Available for Disaster Relief in Dawson County

If you own and live in your home, reside in Dawson County, and are a victim of the June 2010 storms, you may be eligible for disaster relief assistance from the Nebraska Affordable Housing Trust Fund, granted by the Nebraska Department of Economic Development.

The maximum amount of funding per household is \$7,500, which is in the form of a grant. To be eligible homeowners must have annual gross incomes no greater than \$62,000, no matter

what household size. Items generally covered by disaster relief funds are hot water heaters, furnaces, dry wall repair, septic tanks, and decontamination of wells. No mobile homes or personal property items are eligible to the program. Any costs experienced by the homeowner and paid out prior to approval to the program are not eligible for reimbursement. Homeowners insurance must have been in place at the time of loss; Insurance deductibles are eligible for

reimbursement if the work is completed after receiving approval to the program.

Application packets are available at the Gothenburg City Administration Office, the Cozad City Administration Office, and at the Dawson County Courthouse in the County Clerk's office. With questions or inquiries please call West Central Nebraska Development District (WCNDD) at 308-284-6077. WCNDD is administering the program on behalf of the Nebraska Department of Economic Development. The application process will close August 31, 2010 and applicants will be notified in writing if they are accepted to the program. Completed applications should be sent to WCNDD, PO Box 599, Ogallala, NE 69153.

Keep Lexington Beautiful gets \$25,000 from Walmart

NEW! Invasive Species Cost Share Program

Central Platte NRD's Phragmites Control Cost Share Program



75% cost share up to \$2,000 per landowner/operator per contract.

This program will be used for the landowners/entities/etc. that do not qualify for EQIP/WHIP or were unable to get funding due to lack of funds from the NRCS.

Applications

- Can be in the landowner or operators name. If the application is in the operator's name, a form must be signed by the landowner for the operator to pursue practice on their ground.
- Applications will be approved as received each month.

Reason for Program

This program is designed for chemical control of hydrophytic herbaceous (not trees) noxious weed species (Ex. phragmites, purple loosestrife) on riparian areas adjacent to the Platte River, tributaries, and water bodies district wide (ex. road ditches).

Acres that were treated by the state/weed management associations in the last 2 years are not eligible, as the contractor that treated those acres issued a 3-year guarantee.

Contracts

- Contracts last for 3 years. Spraying will be done in year 1, leave it alone in year 2 and then any necessary treatment in year 3. Follow-up treatment may or may not be required or eligible for cost share, depending upon the herbicide used and guarantees associated with the initial treatment.
