

RESOLUTION

A resolution requesting and authorizing either the County Assessor or the County Clerk to divide the levy of special assessments on the real estate herein described.

Section 1. The County Assessor or County Clerk of Dawson County, Nebraska, is hereby authorized and requested to divide and equalize the levy of special assessments as hereinafter set forth:


