

LEGAL DESCRIPTION:

A tract of land being part of the Southwest Quarter of the Northwest Quarter (SW1/4 NW1/4) part of Northwest Quarter of the Southwest Quarter (NW1/4 SW1/4) and part of Southwest Quarter of the Southwest Quarter (SW1/4 SW1/4) of Section Four (4), Township Nine (9) North, Range Twenty-One (21) West of the Sixth Principal Meridian, Dawson County, Nebraska, and more particularly described as follows:

Commencing at a cross chiseled in concrete at the West Quarter corner of Section 4;

thence S 89°59'13" E on the South line of the Southwest Quarter of the Northwest Quarter of said Section 4 a distance of 33.00 feet to a 5/8" rebar with cap on the East right-of-way line of Taft Street in the City of Lexington, Dawson County, Nebraska and the POINT OF BEGINNING;

thence N 00°38'14" E on said East right-of-way line, and all bearings contained herein are relative thereto, a distance

of 353.13 feet to a 5/8" rebar with cap;

thence S 89°31'10" E a distance of 1279.67 feet to a 5/8" rebar with cap on the East line of said Southwest Quarter of the Northwest Quarter;

thence S 00°29'36" W on said East line of the Southwest Quarter of the Northwest Quarter a distance of 342.68 feet to a 5/8" rebar with cap at the Southeast corner of said Southwest Quarter of the Northwest Quarter;

thence S 00°29'28" W on the East line of the Northwest Quarter of the Southwest Quarter and on the East line of the

Southwest Quarter of the Southwest Quarter of said Section 4 a distance of 1376.72 feet to a 5/8" rebar;

thence N 89°31'34" W a distance of 1283.89 feet to a 5/8" rebar on said East right-of-way line of Taft Street;
