CALL TO ORDER:

1. Clarify the original intent of the Planning Commission in Sec. 28-30.9(B), that Billboard Signs must be adjacent to and abutting the named highways;

2. Address Size Limits, Spacing, and limit the types of Lighting;

3. Remove part of Adams Street from the permitted area. Roll call. Voting
