CALL TO ORDER: The meeting was called to order by Chair Worthing who informed the public that the Open Meetings Act is posted in the Meeting Room at the Lexington City Hall, located at 406 East 7th Street, Lexington, Nebraska.

MINUTES–**MEETING 11-3-2021:** Minutes of the Regular Meeting held Wednesday, November 3, 2021, were presented to the Commission for consideration and approval. PUBLIC HEARING: Chair Worthing opened a public hearing to consider an application by Wilkinson Development Inc. for the Wilkinson Addition. Brecks explained the layout of the proposed plat, noting an easement for the sewer lines in the area will need to be included in the final plat. Clarine Eickhoff, Wilkinson Companies COO, noted a redevelopment project application for the area will be submitted at a later date. There being no public comments, the public hearing was closed. Following discussion, moved by Smith, seconded by Roemmich, to make a recommendation to the City Council to approve the proposed Wilkinson Addition with corrections stated. Roll call.
