A regular meeting of the Railroad Transportation Safety District was held on Thursday, September 10, 2009, at 5:00 p.m., in the Lexington City Council Chambers, at 406 E. 7th Street, Lexington, Nebraska. Notice of the meeting was given in advance by publication in the Tri-City Tribune. A copy of the Proof of Publication is on file in the office of the County Clerk. Availability of the agenda was communicated in the published notice and in the notice to members of the RTSD Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Members of the Board of Directors present were Roger Bauer, Bill Stewart, Everett Hagan, Steve Tomasek, John Salem. Absent: Linda Miller. City Officials present were City Manager Joe Pepplichtsch and Assistant City Manager Dennis Burnside. Dawson County Official, Treasurer Sharon Wood. The press was represented by the Kearney Hub.

President Tomasek called the meeting to order at 5:09 p.m. announced that the current open meetings act was posted for the public and the location of the poster.

Motion was made by Bauer and seconded by Hagan to approve the minutes of the July 9, 2009, regular meeting. Aye: Salem, Bauer, Hagan, Stewart, Tomasek. Nay: None. Absent: Miller. Motion carried.

Motion was made by Stewart and seconded by Bauer to approve the claim presented. Aye: Salem, Hagan, Bauer, Stewart, Tomasek. Nay: None. Absent: Miller. Motion carried.

At 5:11 p.m., President Tomasek opened the Public Hearing for the purpose of hearing support, opposition, criticism, or suggestions relating to the proposed 2009/2010 RTSD budget. The proposed 2009/2010 property tax request is \$167,225.00 and the proposed tax rate is 0.010005. At 5:18 p.m., President Tomasek closed the hearing on the budget.

Motion was made by Stewart and seconded by Hagan to approve increasing the base of restricted funds by an additional one-percent (1%). Aye: Salem, Bauer, Hagan, Stewart, Tomasek. Nay: None. Absent: Miller. Motion carried.

Motion was by Salem and seconded by Bauer to approve Resolution #2009-02, proposed 2009/2010 budget. Aye: Bauer, Hagan, Salem, Stewart, Tomasek. Nay: None. Absent: Miller. Motion carried.

Director's Report – as of August 31, 2009 we have \$97,836.43 and an addition \$39,292.06 will be deposited on September 15, 2009.

No person appeared at the time scheduled for Citizen's Comments. At 5:27 p.m., the meeting was adjourned. The next regular meeting is scheduled for Thursday, October 8, 2009, pending any action that needs to be taken.
