A regular meeting of the Railroad Transportation Safety District was held on Tuesday, June 15, 2016, at 5:00 p.m., in the Lexington City Council Chambers, at 406 E. 7<sup>th</sup> Street, Lexington, Nebraska. Notice of the meeting was given in advance by publication in the Lexington Clipper Herald; a copy of the Proof of Publication is on file in the office of the County Clerk. Availability of the agenda was communicated in the publish notice and in the notice to member of the RTSD Board of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Member of the Board of Directors present were John Salem, Everett Hagan, Dennis Rickertsen, Linda Miller, and Bill Stewart. Jeremy Roberts was absent. RTSD Director Joe Peplitsch was present.

President Stewart called the meeting to order at 5:00 p.m. and announced that the current open meetings act was posted for the public and the location of the poster.

No person appeared at the time scheduled for Citizen's comments.

Motion was made by Hagan and seconded by Rickertsen to approve the September 16, 2015 regular meeting minutes. Aye: Rickertsen, Hagan, Salem, Miller, Stewart. Nay: None. Motion carried.

Motion was made by Miller and seconded by Salem to approve the claim as presented. Aye: Rickertsen, Hagan, Miller, Salem, Stewart. Nay: None. Motion carried.

Motion was made by Miller and seconded by Stewart to elect John Salem as President and Dennis Rickertsen as Vice President. Aye: Miller, Rickertsen, Hagan, Salem, Stewart. Nay: None. Motion carried.

Peplitsch reviewed a financial report. The RTSD fund balance is \$524,664.03 as of May 31, 2016. Motion was made by Rickertsen and seconded by Hagan to accept the financial report as presented. Aye: Roberts, Salem, Hagan, Rickertsen, Stewart. Nay: None. Absent: Miller. Motion carried.

Discussion was held on a draft FY 2017 budget. Following discussion a resolution was presented to request tax levy authority. Motion was made by Hagan and seconded by Roberts to approve Resolution #2016-01 as presented. Aye: Salem, Roberts, Hagan, Rickertsen, Stewart. Nay: None. Absent: Miller. Motion carried.
